HVAC Tune-Up Season Is Here

With the arrival of summer, HVAC systems are typically in operation more than any other time of year. Did you know that TNMP will pay HVAC contractors for completing a comprehensive tune-up on your HVAC equipment (excludes chilled water equipment)? Please let your program representative know if your team could use some help with preventative maintenance.

Project Spotlight:

COSTCO IN LEWISVILLE

Costco Wholesale in Lewisville recently completed a retrofit of all HID exterior lighting to an LED solution. The project included pole lights, wallpacks, canopy lights and sign lighting. This retrofit represents an estimated peak demand reduction of **34 kW** and electric consumption savings of **190,000 kWh** per year. For the estimated annual energy savings, Costco was awarded over **\$10,000** in cash incentives through the TNMP Commercial Solutions program.

LED lighting continues to be a top measure for this program. If your facility is still utilizing high-wattage exterior lighting, contact your local TNMP program rep to request an opportunity assessment for a potential lighting retrofit project!



Project Spotlight:

CITY OF GATESVILLE

In partnership with Solar CenTex LLC, the City of Gatesville recently deployed a photovoltaic system at the city's waste water treatment facility. The PV system is estimated to save the city over **95 kW** and **330,000 kWh** annually. The estimated kWh reduction from this project is equivalent to the carbon sequestered by **276 acres** of U.S. forests in one year or the greenhouse gas emissions avoided by **81.9 tons** of waste recycled instead of landfilled.

Technology Spotlight: Exterior Door Air Infiltration

Conditioned air leaking through external doorways is a common deficiency that wastes energy. Installing weather stripping and door sweeps on existing doors that separate a conditioned space from an unconditioned space is a recently approved measure with solid savings potential. The doors must have a visible gap along the exterior perimeter of at least 1/8 inch. Facilities equipped with electric resistance heat possess substantially more savings opportunity than those utilizing gas heat.
